Dear Messrs. Lackey and Taylor:

On January 19, 2013, Sovernet Fiber Corp. (Sovernet) filed an amended petition pursuant to RSA 371:17 seeking approval for licenses to construct and maintain four fiber optic cable crossings over and across public waterways and in one case a railroad, in Lebanon, New Hampshire. The filing indicates that FairPoint Communications – NNE (FairPoint) performed surveys and provided make ready statements.

Staff review indicates that existing attachments as described in Sovernet's filing may not be in compliance with the NESC:

- Mascoma River at Glen Road: Pole GMP 82, FP 44. Existing cable shown as "CATV" 28 inches below neutral (closer than 40 inches).
- Mascoma River at Buckingham Place: Pole GMP 291/135, FP 311/132. Existing cable shown as "Fig 8 Cable" 12 inches below neutral
- Mascoma River at High Street / Route 4: Pole GMP 53/2, FP 60. Existing cable shown as "Fig 8 cable" 27 inches below neutral.
- Mascoma River at High Street / Route 4: Pole GMP 53/1, FP 60/5. Existing cable shown as "Fig 8 cable" 30 inches below neutral.
