Dear Mr. Novello:

On July 19, 2012, the New Hampshire Public Utilities Commission (Commission) received an application from you requesting certification of your photovoltaic array at Wagner Forest Management, Ltd., (Wagner Forest Management) 150 Orford Roadk, Lyme, NH as a Class II renewable energy source pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standard law.

Your original application cannot be considered for REC eligibility until the Commission receives the following information:

- A complete list of the equipment used at the facility, including the meter and, if applicable, the inverter;
- The name, license number and contact information of the installer of the applicable generation or solar heating equipment, or a statement that the equipment was installed directly by the customer;
- The name and contact information of the seller of the applicable generation or heating equipment;
- The name and contact information of the independent monitor of the source. You will find a list of eligible independent monitors at http://www.puc.nh.gov/Sustainable%20Energy/Renewable_Energy_Source_Eligibility.htm;

- A copy of the interconnection agreement pursuant to Puc 307.06. A call to your utility company will make this possible and it provides verification of the system output;
- While the Puc 2500 rules don't require registration with the NEPOOL Generation System (GIS), your facility will need to be registered with the GIS in order to be considered for eligibility. I can process your application without that information, but it usually only takes a phone call and a short process to get your facility listed in the system. Contact information follows:
