Re: DE 12-262 Unitil Energy Systems, Inc. (Core Energy Efficiency Programs) Staff Recommendation to Approve Budget Transfer to Home Performance with ENERGY STAR Program

Dear Ms. Howland:

On September 25, 2014, Unitil Energy Systems, Inc. (the Company) requested the ability to transfer funds within the residential sector of its Core electric energy efficiency programs to meet 2014 year-end demand for its Home Performance with ENERGY STAR (HPwES) program. The Company expects to under-spend in its ENERGY STAR Homes program and K-12 Education program and wishes to transfer \$69,000 from those programs to the HPwES program. The budget transfer represents more than 20% of the approved budget and, therefore, the Company is filing the budget transfer request with the Commission in accordance with Section I (K) of the Commission-approved 2013-2014 Core program.<sup>1</sup>

Staff supports the proposed transfer, with the concurrence of the Office of Consumer Advocate. Absent any comments to the contrary by any interested party within two weeks of the filing, and absent Commission notification within 30 days of the need to conduct an indepth review, Staff believes the transfer will be deemed approved per Section I (K) of the 2013-2014 Core program.
