Dear Ms. Howland:

Per its letter dated December 12, 2013, Staff of the New Hampshire Public Utilities Commission (the "Commission") made, among other things, the following request for additional information of Contoocook Hydro, LLC ("Contoocook" or the "Applicant") pertaining to its Application for Class I certification for a portion of the generation from its Hopkinton Hydro Project (the "Project" or the "Facility"). ¹

• Identify the four improvements that have had the greatest impact on the increased electricity production at the Hopkinton Project, describe the causal connection between these specified improvements and the increases in production, and provide a good faith estimate of the quantity of increased production to each improvement (either in KWh or on a percentage basis).

In its letter dated October 7, 2014, the Applicant provided this information to the Commission; however, Staff objected to the Applicant's request that all of the requested materials be given confidential treatment. The Applicant revised its response, producing both a redacted and confidential versions of this information. Accordingly, enclosed please find Contoocook's revised response to Staff's request for this additional information.
