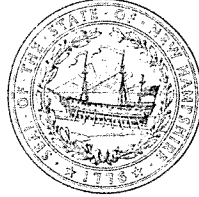

Dear Mr. Ginn:

On April 19, 2013, Union Atlantic Electricity (Union Atlantic) requested a second extension of time, to July 1, 2013, to complete its application to register as a competitive electric power supplier. Union Atlantic stated it required the additional time to meet financial assurance requirements and complete EDI testing with two distribution utilities.

Staff recommends that the Commission approve this request for an extension. Staff also recommends, because Union Atlantic's application has been pending since October 25, 2012 and because this is its second extension request, that the Commission deny any further extension requests.

Based on the foregoing, the Commission has granted Union Atlantic's request for an extension until July 1, 2013 to complete its application for registration as a competitive electric power supplier. Any further requests, however, for extensions under the instant docket will be denied. Accordingly, Union Atlantic's completed application is due July 1, 2013.
