Default Service Rates for the Period November 1, 2013 through January 31, 2014 for the Large and Medium Commercial and Industrial Customer Group and for the Period November 1, 2013 through April 30, 2014 for the Residential and Small Commercial Customer Group

Dear Ms. Howland:

At today's hearing in the above-captioned docket, the Commission issued a record request for information from Granite State Electric Company (Granite State). The request was made in order to provide revised Default Service Rates and to ascertain the impact on such rates when incorporating the rate adder calculated in Exhibit 11 regarding the recent FERC order conditionally accepting ISO-NE's tariff revisions. The FERC's order requires that the cost of ISO-NE's Winter Reliability Program be allocated to Real-Time Load Obligation (i.e. to energy service) rather than to Regional Network Load. In response to that request, we are enclosing one public and seven confidential copies of the following revised attachments to Mr. Warshaw's testimony:

Revised Schedule JDW-9

Revised Schedule JDW-7
Revised Schedule JDW-10

These attachments show a proposed residential Default Energy Service rate of 8.899¢ per kilowatt-hour for the Small Customer Rate for the period November 1, 2013 through April 30, 2014, as shown in Revised Schedule JDW-6, and an average rate of 9.185¢ per kilowatt-hour for large customers for the months of November, 2013 through January, 2014. The monthly proposed rates for the Large Customer Rates are shown in Schedule JDW-7 attached hereto.


The impact by class of the revised proposed rates is shown in Schedule JDW-9 attached hereto.
