On May 20, 2014, the Commission held hearings in the above-referenced proceedings. These rate cases were filed in compliance with the Commission's Order No. 25,292 in Docket No. DW 11-026 wherein the Commission authorized the City of Nashua's acquisition of Pennichuck East Utility, Inc.; Pittsfield Aqueduct Company, Inc.; and Pennichuck Water Works, Inc.

In the hearing regarding Docket No. DW 13-130, the Commission reserved Exhibit 4 for a record request for a copy of the audit conducted by Staff of Pennichuck Water Works, Inc.'s books and records. Enclosed please find that audit.

Also at hearing, Staff, the OCA and the utilities requested the Commission take official notice of the testimony in DW 13-126 pertaining to the DW 11-026 issues and allow the introduction of that testimony in DW 13-128 and DW 13-130. Staff and the parties made this request to make the hearings more efficient and less redundant. The Commission granted that request.

After the hearing, it occurred to Staff, the OCA and the utilities that it would improve ease of tracking the official notice if the DW 13-126 transcript were identified as an exhibit in DW 13-128 and DW 13-130.
