On September 13, 2013, Knollwood Energy of MA, LLC (Knollwood Energy) submitted a request to be registered by the Commission as an aggregator of RECs generated by customer-sited sources pursuant to New Hampshire Code of Administrative Rules Puc 2506. Staff has reviewed Knollwood Energy's request and believes it meets the requirements set forth in Puc 2506.01 for registration as an aggregator of customer-sited sources for applicable NH RECs.

At this time, Knollwood Energy has not yet aggregated any facilities but intends to aggregate New Hampshire customer-sited sources in the near future.

Staff has reviewed the Knollwood Energy request to be registered as an aggregator for RECs generated from customer-sited sources and can affirm it is complete pursuant to New Hampshire Code of Administrative Rules Puc 2506. Based on Staff's recommendation, the Commission hereby approves and registers Knollwood Energy as an aggregator of customer-sited RECs effective September 13, 2013. The New Hampshire certification code for Knollwood Energy to act as an aggregator of RECs is NH-II-13-089. The GIS has assigned Knollwood Energy project code # 14625. Knollwood Energy will have each of its aggregated facilities obtain an independent GIS facility code.
