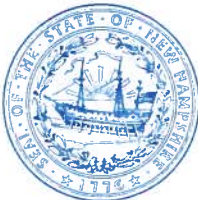

Dear Mr. Hirsh:

On October 03 2013, the Commission received applications from Solar Farm Bank on behalf of Donald Jordan (Jordan), Harmony Energy Investments – Derryfield, LLC (Harmony Energy - Derryfield) and Howard Kalet (Kalet), requesting Commission certification for Class II New Hampshire REC eligibility for photovoltaic (PV) arrays pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law.¹

On October 17, 2013, the Commission received two applications from Solar Farm Bank on behalf of Cherry Hill Limited Partnership – Building 11 (Cherry Hill – Building 11) and Bennett Way Limited Partnership – Building 7 (Bennett Way – Building 7). On October 23, 2013, the Commission received two additional applications from Solar Farm Bank for Mark Flanagan (Flanagan) and Hauch Storage. Certification of these facilities will enable Solar Farm Bank to add these facilities to its aggregation pursuant to Puc 2506.01 and recognized by the New England Power Pool Generation Information System (GIS) under NON 35889.²

¹ Class II eligibility requires a facility to produce electricity from solar technologies that began operation after January 1, 2006 (RSA 362-F:4, II).

² The Commission approved Solar Farm Bank as an aggregator of RECs on February 05, 2013, DE 12-343.

Staff has reviewed these applications and has recommended approval of the above-named applicants' photovoltaic arrays as eligible to be aggregated by Solar Farm Bank for Class II RECs effective October 3, 2013 for Jordan, Harmony Energy – Derryfield, and Kalet; effective October 17, 2013 for Cherry Hill – Building 11 and Bennett Way – Building 7; and effective October 23, 2013 for Flanagan and Hauch Storage. These effective dates are the dates upon which Staff was able to determine that the applications were complete.

Since these facilities are customer-sited sources, their output is not recorded in the ISO New England Market Settlement System and, as a result, must be monitored and verified by an independent monitor. The applications state that Paul Button, Energy Audits Unlimited, will monitor all of these facilities' output pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. Mr. Button will report these facilities' total output annually to the customers, the Commission, and the GIS as part of Solar Farm Bank's Class II aggregation pursuant to Puc 2505.09(h)(3).
