Application to Renew Registration as Provider of Natural Gas Aggregation Service

Dear Ms. Hensey:

On October 16, 2013, SourceOne, Inc. (SourceOne) submitted an application with the Commission to renew its registration as a provider of natural gas aggregation service. Staff reviewed the application and determined that it is complete. Staff noted that the application was not filed within 60 days of the currently expiring registration as required by N.H. Admin Code Puc 3003.05(a). Staff recommended that the Commission approve the application as a renewal, rather than consider it as a new application, inasmuch as SourceOne acknowledged it did not timely submit its renewal and this is the first time SourceOne has been tardy with its filing.

The Commission approves your application to renew your registration as a provider of natural gas aggregation service, effective October 12, 2013. The registration is for a term of 5 years and expires at the end of business on October 11, 2018. Pursuant to N.H. Code Admin. Rule Puc 3003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before August 12, 2018.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:
