On November 21, 2013, the Commission received an application filed by Energetic Enterprises, Inc. (Energetic Enterprises) for the Baltic Mill Enterprises 0.375 megawatt Hydroelectric Project (Baltic Mill) in Enfield, New Hampshire. Energetic Enterprises is requesting Class IV New Hampshire Renewable Energy Certificate (REC) eligibility for Baltic Mill. On December 27, 2013, Staff sent Energetic Enterprises a letter requesting additional information; a response to Staff's letter was received on May 13, 2014.

Staff reviewed the Energetic Enterprises' certification request for the Baltic Mill facility and determined that it meets the eligibility requirements as a Class IV hydroelectric facility and complies with the New Hampshire Code of Administrative Rules Puc 2500. Based on review of the application, Staff recommended that the Commission certify the Baltic Mill facility as eligible for Class IV RECs, effective as of May 13, 2014, the date all information was received to complete the application.

Pursuant to Chapter 272, Laws of 2012, existing small hydroelectric facilities with a total nameplate capacity of one MW or less are eligible for Class IV RECs if they are in compliance with applicable Federal Energy Regulatory Commission (FERC) fish passage restoration requirements, and are interconnected with an electric distribution system located in New Hampshire.

The Baltic Mill facility is located on the Mascoma River, at 80 Baltic Street in Enfield, New Hampshire. The project was built prior to enactment of the Federal Power Act and has been in near continuous operation since its construction in 1886, thereby

Website: www.puc.nh.gov relieving it from the obligation to obtain a license or exemption from FERC. Energetic Enterprises provided documents from the N.H. Department of Environmental Services indicating that Baltic Mill is a permitted and registered dam that is currently in compliance with the Dam Bureau's rules and regulations. A copy of the interconnection agreement between Granite State Electric Company and Energetic Enterprises dated as of December 16, 1988, as assigned to New England Power Company on or about June 28, 2012, was provided with the application.

The Commission has reviewed the Baltic Mill application and has determined that all the necessary documentation has been provided to demonstrate that it is eligible for Class IV certification. Therefore, the Commission hereby certifies Baltic Mill as a Class IV renewable energy source eligible to be issued New Hampshire Class IV RECs, effective as of May 13, 2014.

The Baltic Mill facility's NEPOOL generation information system (GIS) facility code is MSS 951. Attached please find a copy of the notice of this certification provided to the GIS administrator. The New Hampshire Renewable Portfolio Standard certification code for Baltic Mill is NH-IV-14-062.

Please be advised that the New Hampshire Public Utilities Commission has certified the Baltic Mill hydroelectric facility (Baltic Mill) as a Class IV renewable energy source, effective as of May 13, 2014, pursuant to N.H.
