Dear Ms. Rodriguez:

On January 8, 2014, Ambit Northeast, LLC d/b/a Ambit Energy (Ambit) filed an application with the Commission to register as a competitive electric power supplier (CEPS). The application included a certificate demonstrating it had completed electronic data interchange (EDI) testing with PSNH. On February 14, 2014, Ambit filed a surety bond and a copy of its terms and conditions for residential and small commercial customers. The application was completed on March 7, 2014, when Ambit provided a copy of a Secretary of State certificate stating it is registered to do business in New Hampshire.

Staff filed a memorandum on March 11,2014, noting that Ambit provided evidence that it completed EDI testing with only one distribution utility, PSNH, and recommending that the Commission approve Ambit's application as a CEPS authorized to operate only in the franchise area of PSNH. Staff also recommended that Ambit be informed that the Commission's financial security rules for CEPS are likely to change before December 2014, and that Ambit should monitor the rulemaking process and plan accordingly.

The Commission has reviewed Ambit's application and Staff's recommendation and has approved the application as recommended. Accordingly, Ambit's application to register as a CEPS authorized to operate only in the PSNH franchise area is granted, effective as of March 12, 2014. If Ambit seeks to extend its operations to the franchise areas of other distribution utilities, it must file a request for such extension with the Commission and evidence that it has completed EDI testing with those other distribution utilities.

This registration is for a term of 5 years and expires at the end of business on March 11, 2019. Pursuant to N.H. Code Admin. Rule Puc 2003.02(a), Ambit must submit its next renewal application at least 60 days prior to the expiration of the registration approved here, on or before January 11, 2019.

Please be aware that registered CEPSs are subject to specific requirements contained in Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at: http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf. Finally, as noted above, the financial security rules set out in Puc 2003.05(a)(5) are likely to change. Please monitor the Commission's website for notice of this rulemaking process and plan accordingly.
