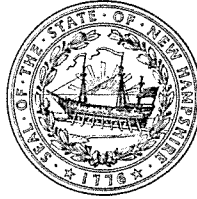

Dear Ms. Cvitkovic:

On April 24, 2014, the Commission issued a secretarial letter announcing its approval of Mint Energy, LLC's (Mint) application to register as a competitive electric power supplier (CEPS). The letter incorrectly stated that Mint provided an electronic data interchange (EDI) certificate issued by New Hampshire Electric Cooperative (NHEC), that Staff recommended the Commission authorize Mint to operate only in the franchise area of NHEC, and that Mint is authorized to operate only in the NHEC franchise area, for a term beginning April 24, 2014 and ending April 16, 2015. The letter should have stated that Mint provided an EDI certificate issued by PSNH, that Staff recommended the Commission authorize Mint to operate only in the franchise area of PSNH, and that Mint is authorized to operate only in the PSNH franchise area, for a term beginning April 24, 2014 and ending April 16, 2015.
