The applications state that NHEC will monitor the facilities' output as required by N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. The total output from these facilities will be included as part of the NHEC Class II Aggregation's total output reported to the NEPOOL Generation Information System as approved by the Commission on April 9, 2010.

The Commission has determined that NHEC has provided all the information necessary to demonstrate these facilities' eligibility for certification and hereby certifies the above named PV arrays as eligible for Class II RECs and inclusion in the NHEC aggregation effective as of the dates listed in the table above.
