On September 26, 2014, the Commission received applications filed by the New Hampshire Electric Cooperative (NHEC) requesting Class II eligibility for NHEC member photovoltaic (PV) arrays¹ and inclusion in the NHEC aggregation.² The applicants include: Margaret Yatsevitch (Yatsevitch), Jonathan Glass (Glass), Doug Campbell (Campbell), David Cunis (Cunis), Richard Thompson (Thompson), Simon Carr (Carr), and Thomas Wallace (Wallace).

Staff has reviewed these applications and has recommended approval of these PV arrays as eligible for Class II RECs and inclusion in the NHEC aggregation as listed in the following table:

¹ Pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law Class II eligibility requires a facility to produce electricity from solar technologies that began operation after January 1, 2006 (RSA 362-F:4, II).

² The Commission granted NHEC Independent Monitor status on May 12, 2009 (DE 09-006). On April 9, 2010, the Commission granted NHEC the authority to aggregate customer-sited sources pursuant to Puc 2506 (DE 10-060).

These facilities are customer-sited sources. Their output is reported as part of the NHEC aggregation to the New England Power Pool Generation Information System (NEPOOL-GIS) as NON32900. In addition to reporting each source's output to the Commission, NHEC will include the total output of these facilities when it reports the total output of all of its Class II eligible facilities to the NEPOOL-GIS, under the name *NHEC Class II Aggregation*. NHEC also serves as the Independent Monitor for these sources.⁴

The Commission has determined that NHEC has provided all the information necessary to demonstrate these facilities' eligibility for certification and hereby certifies the above named PV arrays as eligible for Class II RECs and inclusion in the NHEC aggregation effective as of the dates listed in the table above.
