I wrote to PUC on short notice before the Precedent Agreement meeting with Liberty Utilities but I don't know if the letter was read before the meeting even though I paid for expedited delivery.

I heard PUC is willing to listen to us so I am writing again as there are so many hundreds of reasons why this pipeline is a devastating and destructive act that will forever harm ecosystems and people, not for need, but purely and unequivocally for greed.

I don't want to bog you down with all those reasons so I'm selecting two. Not because they are the worst scenarios, but just to demonstrate how heartless and uncaring and how extreme corporations can be for money. They have no souls. It's beyond belief what they will do.

1. I live in New Ipswich. There is no public water supply in New Ipswich. Everyone and every living thing in this

town relies on wells and aquifers. The wetlands and underground water supplies will be blasted to bits and filled with toxins. Over time, we will become a town filled with houses with no normal water supply into our homes. This will be FOREVER.

FOREVER is a very, very , very long time. There is no means available today to remove the toxins that travel within the complexities of the geology that exists here. Love Canal can never be cleaned. Superfund sites can be improved but never, in anyone's lifetime, can they be restored to prior pristine conditions. Our water is some of the best remaining on the planet. Who would dare dream up a plan to destroy these amazing and rare resources for personal profit. WHO?

2. Kinder Morgan has no remorse about putting a compressor station close to the Temple Elementary School. No remorse for the health damage proven to occur to those living near compressor stations. No second thoughts about causing bodily harm, even to babies yet to be born. Who would dare dream up a plan to destroy innocent human beings <u>for personal profit</u>. WHO?

Please help stop this pipeline. <u>Please.</u> When is someone who is a part of this unforgivably evil process going to finally have the courage to look these companies straight in the eye and say, "No, you do not have, and will never have, my permission to do what you are proposing to do."
