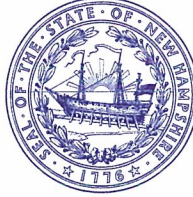

To the Parties:

On December 11, 2015, Staff refiled their revised Energy Efficiency Resource Standard (EERS) proposal. On December 14, 2015, the Office of Energy and Planning (OEP) filed a request for additional time to serve discovery on PUC Staff based on the delay. The parties concurred with the change to the schedule and no party objected.

The Commission has determined that the modification to the procedural schedule is in the public interest and therefore has approved it. Accordingly, the following schedule applies to this round of discovery only. The schedule going forward remains the same:
