On March 7, 2016, the Commission received a petition for late intervention from MCR Performance Solutions, LLC. MCR sought very limited intervention, to which the Electric and Natural Gas utilities jointly responded on March 14.

Please be advised that the Commission has denied MRC's petition inasmuch as it does not have any rights, duties, privileges, immunities or other substantial interests that may be affected by the proceeding. Further, MRC can participate in the proceeding without being made a party and thus, does not qualify for discretionary intervention. RSA 541-A:32 (I) (b). Nonetheless, denial of MRC's intervention request should not prevent its participation in this docket. MCR has access to all docket and other related materials on the Commission's website and may make public comments at the hearing or file written comments pursuant to N.H. Code of Admin. Rules Puc 202.06.
