Electric and Natural Gas Utilities Energy Efficiency Resource Standard

**Petition for Intervention**

Petitioner, the New Hampshire Community Action Agencies Southern New Hampshire Services, Inc. and Belknap-Merrimack Counties, Inc, moves for leave to intervene in this proceeding pursuant to Rule Puc 203.02 and RSA 541-A:32,I(b) and states as follows:

1. Petitioner, the New Hampshire Community Action Agencies Southern New Hampshire Services, Inc. (SNHS) and Belknap-Merrimack Community Counties (BMCA), are two of New Hampshire's five Community Action Agencies which are: Community Action Program Belknap-Merrimack Counties; Southwestern Community Services; Southern New Hampshire Services; Community Action Partnership of Strafford County; and Tri-County Community Action Program.
2. Petitioner representatives will be Ryan Clouthier, Energy Director of Southern New Hampshire Services (SNHS) and Tim Lenahan, Director of Housing Rehabilitation and Energy Conservation of Community Action Belknap-Merrimack Counties (BMCA).
3. Petitioner member agencies operate programs designed to provide food, child care, transportation, energy and other assistance to over 45,000 to 50,000 New Hampshire low income households.
4. Petitioner has an interest in this proceeding, as member agencies work directly with many low income residential electric customers and customers whose homes use natural gas as a heating fuel.
5. Petitioner was a full party intervenor in previous dockets relative to low income households and ratepayers.
6. Petitioner agrees to abide by the procedural schedule set by the Commission for this proceeding.
7. Petitioner seeks to intervene as a full party intervenor in this proceeding.
8. Petitioner agrees to be bound by all protective orders with respect to treatment of confidential information and documents.
9. The granting of this Petition will not impair the orderly and prompt

conduct of this proceeding, will not result in delay, and will not prejudice the interest of any party.


