On April 4, 2016, Direct Energy Business, LLC (Direct Energy Business), a competitive electric power supplier currently authorized to provide service in the franchise areas of New Hampshire Electric Cooperative, Inc., Liberty Utilities, and Public Service Company of New Hampshire, d/b/a Eversource Energy, filed a request to expand its service area to include the franchise area of Unitil Energy Systems, Inc.
