On September 16, 2015, 186 Communications, LLC (186 Communications) filed a petition for two Commission licenses under New Hampshire RSA 371:17 for crossings of the Ammonoosuc River in Littleton, New Hampshire. On September 22, 2015, Staff sent a letter to 186 Communications explaining that the particular crossings the company described are more appropriately licensed under the RSA 371:17-a notification process. 186 Communications filed a letter on September 28, 2015, supplying further information and asking the Commission to treat its filing as a 371:17-a notification.

The information provided by the company describes two fiber-optic crossings, each to be constructed between two existing utility poles, across public waters in the town of Littleton. For each crossing the notification includes:

- a) A description of the specific geographic location;
- b) A description of the pole locations;
- c) Evidence that a pole attachment license has been submitted to the pole owners; and
- d) An affidavit signed by the officer responsible for the construction of this crossing, stating that the crossing will be constructed in accordance with both the National Electrical Safety Code and any requirements of the pole license.

In Staff's assessment this notification meets all the requirements of RSA 371:17-a, and therefore a license for each of the two crossings may be issued pursuant to RSA 371:20.
