## Dear Attorney Fossum:

The Commission has reviewed your Petition for Approval of Lease Agreement between PSNH d/b/a Eversource Energy and Northern Pass Transmission LLC and finds that it does not contain sufficient information for the Commission's review of the petition. Pursuant to New Hampshire Code of Administrative Rules Puc 203.05(b), the petition is deficient and shall not be deemed to have been filed until the deficiency is corrected.

To correct the deficiency, the following additional items are required:

- 1. Copies of the deeds showing PSNH ownership of the fee-owned Leased Properties listed in the attachment to the petition titled "Lease Agreement" on pages bates numbered 42-53 of the attachment;
- 2. Copies of each of the source easement deeds listed in the attachment to the petition titled "Lease Agreement" on pages bates numbered 54-92 of the attachment; and
- 3. For each of the easement deeds listed in the attachment to the petition titled "Lease Agreement" on pages bates numbered 54-92 of the attachment, a legal opinion that the leased use is permitted under the easement and that the easement rights are transferrable to Northern Pass Transmission, LLC by lease.

Upon receipt of the requested additional information, the petition shall be deemed filed for review by the Commission. Given the volume of documents needed for the Commission's

review of this petition you are encouraged to work with Commission Staff concerning a waiver of the filing rules, Puc 203.02, to avoid duplicate copies of these documents.
