- 4. Article 18.5: all references to the dates set forth in Articles 2.3 and 4.1 shall be deemed to refer to the amended and extended dates set forth in this Amendment.
- 5. In all other respects, the Lease as amended and extended hereby is declared by the parties to be in full force and effect in accordance with all its terms and provisions.
- 6. This Amendment may be executed by the parties in one or more counterparts, each of which shall be considered part of the same single document.
