# Re: DM 15-496, Nordic Energy Services, LLC Competitive Electric Power Supplier Application Denial of Confidential Treatment for Customer Contract Form

Dear Ms. Singer:

On December 10, 2015, Nordic Energy Services, LLC (Nordic Energy) filed an application to register as a competitive electric power supplier (CEPS). Nordic Energy's filing included a motion for confidential treatment of (1) its listing of the number and type of customer complaints during the most recent calendar year, and (2) its proposed form of residential and small commercial customer contract. On March 4, 2016, Nordic Energy withdrew its request for confidential treatment of the listing of customer complaints, but maintained its request for confidential treatment of the proposed form of residential and small commercial customer contract. On April 14, 2016, Nordic Energy filed, under claim of confidentiality, proposed final revisions to its residential and small commercial customer contract.

Commission Staff (Staff) filed a memorandum on April 15, 2016 stating its position that contracts intended for transactions with residential and small commercial customers should not be afforded confidential treatment by the Commission. In Staff's view, all residential and small commercial customer contracts filed by a CEPS and reviewed by the Commission should be publicly available for inspection, especially by potential customers of the CEPS, and not be limited to review by only Staff and the Commission. Staff emphasized the importance of contract terms transparency, in particular as a means of enabling informed decisions by customers choosing among offers from different CEPS. Staff further indicated it is unaware that any other CEPS has been granted or even requested confidential treatment for its residential and small commercial customer contract form(s). According to Staff, the contract forms used by Nordic Energy's CEPS competitors therefore are publicly reviewable by both prospective and current customers, and Nordic Energy's contract form should be as well.

Based on these considerations, Staff concluded that Nordic Energy has little or no privacy interest in its proposed form of residential and small commercial customer contract, and whatever privacy interest it may have in the contract form is outweighed by the public interest in its disclosure. Staff recommended that the Commission deny confidential treatment of Nordic Energy's form of residential and small commercial customer customer contract, and direct Nordic Energy to file a public, unredacted version of the complete contract form within 30 days of such denial.

The Commission has reviewed Nordic Energy's request for confidential treatment of its form of residential and small commercial customer contract and Staff's recommendation that confidential treatment be denied. The Commission has found that any possible privacy interest of Nordic Energy in the contents or format of such contract form is outweighed by the substantial public interest in its disclosure, for the reasons identified by Staff in its recommendation.

The Commission therefore has denied Nordic Energy's request for confidential treatment and has directed Nordic Energy to submit a public, unredacted version of its form of residential and small commercial customer contract within 30 days of the date of this letter. Accordingly, Nordic Energy must file a public, unredacted version of its complete residential and small commercial customer contract form by May 19, 2016.
