**Re: DM 16-064, Global Montello Group Corp.'s Request to Cancel/Abandon its  
Competitive Natural Gas Supplier License**

Dear Sir/Madam:


Global Montello Group Corp. ("Global") desires to cancel/abandon its Competitive Natural Gas Supplier License and accordingly, states as follows:

- 1) On February 1, 2017, Global Montello Group Corp. sold its natural gas marketing business to Sprague Operating Resources LLC ("Sprague");
- 2) By letter dated January 31, 2017, Global requested a waiver from the Commission of the 30-day notice requirement contained in Puc 3004.04 (l) and (m) and filed a proposed form of the notice letter with its waiver request;
- 3) By letter dated February 6, 2017 (a copy of which is enclosed), the Commission notified Global that Global's waiver from the relevant provisions of Puc 3004.04 (l) and (m) was granted;
- 4) Consistent with the terms of the waiver, Global notified its natural gas supply customers that as part of its sale to Sprague, their natural gas supply contract with Global will be transferred to Sprague after at least thirty (30) days following their receipt of Global's notice; and

Global confirms that in addition to the above, it has complied with all other applicable rules contained in Puc 3000 and respectfully requests the Commission's approval to cancel/abandon its Competitive Natural Gas Supplier License.
