To the Parties:

On March 7, 2017, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed a stipulation and settlement agreement in the instant docket along with a request for waiver of the procedural deadlines governing this proceeding, specifically the February 21, 2017 deadline for filing rebuttal testimony or a settlement. In support of its request for a waiver, Eversource notes that the settlement is among all the parties and resolves all issues presented in this matter. Moreover, the settlement has been filed more than 5 days prior to the March 22, 2017 hearing.

The Commission has found that the requested waiver will not disrupt the orderly and efficient resolution of matters before the Commission and will serve the public interest. Accordingly, the requested waiver of the procedural deadlines has been granted and the stipulation and settlement agreement has been accepted.
