**AUTHORIZATION FOR CLASS I- THERMAL RENEWABLE
ENERGY CERTIFICATE (REC) ELIGIBILITY**

The Commission received and Staff reviewed the Eric Christian (Christian) application for Class I Thermal REC eligibility for the 0.009 megawatt equivalent geothermal facility installed at 23 Country Side Drive, Nashua, New Hampshire. In addition, the Christian facility is requesting inclusion in the Revolution Energy Aggregation, LLC (REA). **Based on Staff's recommendation, the Commission hereby approves the Christian geothermal facility as fully eligible for Class I-T REC production, and inclusion in the REA, effective as of June 27, 2016.**
