To the Parties:

On August 22, 2016, the Commission approved a temporary water connection and special contract between Aquarion Water Company of New Hampshire, Inc. ("Aquarion") and the water supply system of Wiggin Farm Homeowner's Association. At that time, it was unclear whether the connection would be made permanent, and the Commission scheduled a status conference for October 5. On October 3, Aquarion moved to close this docket and stay the status conference indefinitely. Aquarion stated that the temporary connection has been terminated and that there is no present schedule for making a permanent connection. Based on these representations, the Commission canceled the status conference scheduled for October 5 and closed the docket.
