Dear Ms. Mastorides:

On November 2, 2018, you filed a request with the Commission to withdraw the registration of Customer Acquisition Specialists of America, Inc. d/b/a CASA-North American Energy Advisory (Customer Acquisition) as a natural gas aggregator in New Hampshire. In your letter, you stated that Customer Acquisition ceased doing business in New Hampshire on January 1, 2018. Staff filed a memorandum on November 5, 2018, noting it had been informed that the company has not served any customers during the past 30 days and recommending that the Commission grant rule waivers to permit the termination of the company's registration.

The Commission's rules governing natural gas aggregators do not provide for the withdrawal, rescission, or abandonment of an aggregator's registration. The Commission has reviewed your letter and Staff's memorandum and has deemed the letter a request for waivers of N.H. Code Admin. Rules Puc 3003.05 (e) (approved aggregator registration renewal valid for five years), and Puc 3003.05 (g) (registered aggregator to continue compliance with requirements of Puc 3000).

The Commission has determined that the requested waivers, without any further conditions, are in the public interest and will not disrupt the orderly and efficient resolution of matters before the Commission, and that the purpose of the rules will be satisfied by the termination of Customer Acquisition's natural gas aggregator registration, effective as of the date specified in the request letter.

Accordingly, Customer Acquisition's natural gas aggregator registration is deemed withdrawn and terminated, effective as of November 2, 2018.
