These Tariff Pages reflect corrections or additions to the Tariff Pages submitted in Northern's September 16, 2016 filing which were uncovered by parties attending the Company's October 3, 2016 technical session in the above referenced proceeding.

First Revised Page 55 (Local Delivery Adjustment Clause "LDAC"),
Fifteenth Revised Page 96 (Rate Summary),
Original Page 96.1 (Rate Summary),
Fifteenth Revised Page 97 (Rate Summary),
Original Page 97.1 (Rate Summary),
Sixth Revised Page 98 (Rate Summary),
Original Revised Page 98.1 (Rate Summary),
Third Revised Page 171 (Appendix D).

The above listed Tariff Sheets are issued October 6, 2016 by Mark H. Collin, Senior Vice President, to be effective November 1, 2016. Red lined versions of these Tariff Sheets are also included.

First Revised Page 55 (LDAC) contains a correction to the last paragraph that replaces the term "Winter" period with "annual" period.

Fifteenth Revised Pages 96 and 97, and Sixth Revised Page 98 (Rate Summaries) are included to reflect the change in the LDAC effective January 1, 2017 and the corresponding impact on total billed rates. These Tariff Pages were omitted in Northern's September 16, 2017 filing.



Original Pages 96.1, 97.1 and 98.1, (Rate Summaries) have been corrected to reflect the proposed 2017 LDAC rates which include the Lost Revenue Rate component proposed for effect January 1, 2017.

Third Revised Page 171 (Appendix D) has been revised due to a discrepancy between the Re-entry Rate submitted in this Docket and the Re-entry Rate submitted under separate cover on September 16, 2016. A comparison of these rates revealed that the Re-entry Rate submitted in the initial COG was incorrect due to a typographical error.
