(the "Company") for approval to effectuate a name change in Enhanced Communications of Northern New England Inc.'s fictitious business name from FairPoint Long Distance – NNE to Consolidated Communications Long Distance.

By this letter, Enhanced Communications of Northern New England Inc. requests a letter of authorization from the Commission changing its certificated name from Enhanced Communications of Northern New England Inc. d/b/a FairPoint Long Distance - NNE to Enhanced Communications of Northern New England Inc. d/b/a Consolidated Communications Long Distance, with an effective date of February 19, 2018.
