Re: DT 17-100: Northern New England Telephone Operations LLC: Intrastate Access Tariff  
Revisions and Waiver Requests


On June 14, 2017, Northern New England Telephone Operations LLC (FairPoint) submitted a filing to revise its common intrastate access tariff for effect on July 1, 2017, pursuant to the Federal Communications Commission (FCC) Report and Order FCC 11-161 (Transformation Order). Consistent with the Transformation Order, as revised, the tariff filing proposes to set FairPoint intrastate access rates equal to current FairPoint interstate rates. FairPoint also requested waivers of Puc 1603.07(a)(1), which requires 30 days' notice before a tariff change becomes effective, and of Puc 1604.05(d), which requires a utility to formally request a waiver allowing a tariff to take effect before the 30 days have elapsed.

Staff reviewed the proposed tariff changes for compliance with FCC orders and rules, and following its investigation, recommended that those proposed changes be allowed to go into effect. To enable this, Staff recommended that the waiver of Puc 1603.07(a)(1) be granted. Staff concluded that no waiver of Puc 1604.05(d) is necessary, since FairPoint's filing of June 14, 2017 satisfies that rule.

The Commission has accepted Staff's recommendation that the proposed tariff changes be allowed to take effect. The Commission grants a waiver of Puc 1603.07(a)(1) allowing these changes to take effect in less than 30 days after filing. The Commission considers FairPoint's filing of June 14, 2017 to be a sufficient notice under Puc 1604.05(d), and declines to issue a waiver of that rule, finding such a waiver to be unnecessary.

For administrative efficiency, an order will not be issued by the Commission either suspending, rejecting, or approving the proposed tariff changes. Pursuant to RSA 378:3 and RSA 378:6, IV, the proposed tariff changes, filed on June 14, 2017, and pursuant to Staff's recommendation, are effective, as proposed, on July 1, 2017. Tariff pages should be filed referencing Docket No. DT 17-100 and reflecting the effective date of July 1, 2017.
