MOTION TO ENTER TESTIMONY OF JUSTIN R. BARNES INTO THE RECORD AND REQUEST TO SUBMIT WRITTEN CLOSING STATEMENT

6. Sunrun and ReVision respectfully request an opportunity to submit a written closing statement within a reasonable time as determined by the Commission upon the conclusion of the Settlement Hearing.

WHEREFORE, Sunrun and ReVision request the Commission grant this motion to enter the testimony of Justin Barnes into the record as testimony in the above referenced docket and that the Commission grant parties the opportunity to submit written closing statements following the conclusion of the hearing.
