To the Parties:

On March 21, 2018, Staff filed a request for additional time to review the Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities – Keene Division's technical proposed tariff filing for the calculation of standard heat content value. Staff requests that the tariff suspension period be extended for an additional 5 months to permit additional time for Staff's evaluation to be completed.

The Commission has reviewed Staff's recommendation and has determined that the tariff filing should be suspended as recommended by Staff. Accordingly, Liberty's tariff filing for the calculation of standard heat content value made on November 27, 2017 is suspended pursuant to RSA 378:6, I(b) for an additional 5 months or until August 23, 2018.
