2018 Energy Service Solicitation

Dear Director Howland,

On December 29, 2017, in Docket No. DE 17-113, the Commission issued Order No. 26,092 approving a settlement specifying the method for Public Service Company of New Hampshire d/b/a Eversource Energy ("Eversource") to transition from its traditional method of procurement of energy for its default Energy Service ("ES") rate, to one based upon competitive solicitation. Relevant to this submission, in that settlement the new ES rate was to take effect within approximately 90 days following the closing on the sale of Eversource's thermal generating assets. The settlement set out a proposed representative schedule for ES procurement and subsequent rate approval, presuming that the sale of the thermal assets was to occur by the end of 2017 and that a Request for Proposals ("RFP") could be issued by January 5, 2018. Based upon that schedule, the new ES rate would take effect on April 1, 2018.

The closing on the thermal assets was delayed until January 10, 2018, and, as a result, the issuance of the RFP is occurring on January 12, 2018, rather than January 5. The brief delay in the issuance of the RFP from the schedule set out in the settlement agreement, however, does not require any delay in the implementation of the new ES on April 1, 2018. Accordingly, Eversource provides the below schedule (which is substantially the same as that included in the settlement in Docket No. DE 17-113) as the schedule it proposes for implementing the new ES rate on April 1, 2018 as contemplated in the settlement in Docket No. DE 17-113 and Order No. 26,092.
