**Petition for License to Cross Public Waters of
Lake Winnepesaukee in the Town of Meredith**

Summary of Order *Nisi* No. 26,182 Granting Water Crossing License

October 25, 2018

On October 25, 2018, the Commission approved a request by New Hampshire Electric Cooperative, Inc. (NHEC), under RSA 371:17 for a license to reconstruct and maintain an electric line under and across Lake Winnepesaukee in Meredith, New Hampshire. The Commission's order, along with the petition and subsequent docket filings, other than any information for which confidential treatment is requested of or granted by the Commission, is available at <http://puc.nh.gov/Regulatory/Docketbk/2018/18-087.html>.

The Commission determined that the proposed crossing is necessary to meet the reasonable requirements of service to the public and that the license could be granted without substantially affecting public rights in Lake Winnepesaukee at the location of the crossing. The Commission approved NHEC's license request subject to certain conditions related to the safe construction, operation, and maintenance of the proposed crossing.

The Commission delayed the effectiveness of its approval of NHEC's request to ensure that the public receives notice of the Commission's determination and has an opportunity to file comments or to request a hearing. All persons interested in responding to the Commission's action may submit their comments, or file a written request for a hearing that states the reason and basis for a hearing, no later than November 13, 2018. Any person(s) responding to such

comments and requests for hearing shall do so no later than November 20, 2018. Following consideration of any comments and requests for hearing received, the Commission may further extend the final effective date of its order. The Commission's order shall become final and effective on November 26, 2018, unless the Commission orders otherwise.
