According to the procedural schedule issued by the Commission on October 2, 2018, in the above-referenced proceeding, a hearing is scheduled for December 12, 2018, at 1:30 p.m. Both Abenaki Water Company, Inc., and Tioga River Water Company, Inc., notified Staff that, as of close of business on December, 6, 2018, a settlement agreement had not been achieved. Issues remain between the parties, including the possible removal of meters owned by the Town of Gilford involved in this franchise, that require additional time for further investigation. Those issues prevent a meeting of the minds on all sides.
