On behalf of Commission Staff (Staff) in the above captioned matter, I write to ask the Commission to schedule a follow-up technical session in this docket for September 27, 2019, from 9:30 a.m. to noon. This additional technical session will allow the parties to develop issues raised at the September 23, 2019, technical session. Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities (Liberty) and the Office of Consumer Advocate (OCA), concur in this scheduling request.
