CONSENT DECREE

A. Introduction

1. Petitioner, the New Hampshire Dept. of Environmental Services (“Department”), through its counsel, the Office of the Attorney General (collectively the “State”), and the respondent, Saint-Gobain Performance Plastics Corporation, through its counsel Christopher Gibson, Esquire, (“Respondent”), hereby agree to the terms and conditions set forth in this consent decree (“Consent Decree”), in resolution of the State’s petition in this case. Although the parties intend to have this decree entered as an order of the Court, the decree shall become binding upon signature by both parties.

2. This suit involves the presence of Perfluorooctanoic Acid (“PFOA”) and Perfluorooctane Sulfonic Acid (“PFOS”) (collectively the “PFCs”) in groundwater and certain water supply wells in portions of the towns of Bedford, Litchfield, Manchester, and Merrimack, New Hampshire (the “Towns”).

3. The State alleges that the Respondent’s facility located at 701 Daniel Webster Highway in Merrimack, New Hampshire (the “Property”) is a source of the PFCs detected in certain portions of the Towns, specifically including the portions of the Towns located within the “preliminary Groundwater Management Zone” or “pre- GMZ” as described herein and as shown

on Exhibit C, and, therefore, the State further alleges that the Respondent is responsible for the investigation and remediation of the PFCs, including the provision of alternate drinking water to property owners whose water supply wells have been found to contain PFCs in excess of the State's Ambient Groundwater Quality Standard or "AGQS" as defined in Env-Or 602.02.

4. The Respondent and the State have been working cooperatively since March 2016 to investigate and remediate the presence of PFCs in groundwater and water supply wells in the Towns and to evaluate additional potential remedial options. As part of these efforts, over 1,500 samples have been collected from groundwater, surface water, or water supply wells in the Towns. In addition, the Respondent has voluntarily: (a) provided bottled water to residents living in the Towns; (b) paid for municipal water lines to be extended to 368 properties in Litchfield, 26 properties in Manchester, and 18 properties in Merrimack, as set forth in Exhibit A; and (c) provided Point-of-Use ("POU") treatment systems for 56 properties in Litchfield and Bedford, as set forth in Exhibit B (collectively the "Completed Work"). In addition, this Consent Decree requires the Respondent to offer to provide alternate drinking water to other properties in portions of the Towns within the pre-GMZ. Those properties at which work has already been completed together with those properties for which this Consent Decree requires the Respondent to provide or offer to provide alternate drinking water will collectively be referred to as the "Addressed Properties."

5. Pursuant to RSA 485, RSA 485-C, RSA 147-A, RSA 147-B, and Env-OR 601, et seq., the Respondent and the State have agreed to the completion of certain additional remedial measures to address PFCs in groundwater and water supply wells in the portions of the Towns within the pre-GMZ. These measures shall include: further expansions of the municipal water systems in certain portions of the Towns; the final establishment of a GMZ, which is currently

presumptively limited to the area set forth in Exhibit C but subject to modification as set forth in Paragraphs 27 through 29; and, the submission and implementation of a Remedial Action Plan as provided for by rule.

6. The Parties currently anticipate that, given the current concentrations of PFCs, their distribution, and their potential source, monitored natural attenuation (“MNA”) for all areas other than source areas, i.e., areas of high concentration of PFCs attributable to the Respondent that require treatment to prevent the further spread of PFCs¹, together with the provision of safe drinking water, will be an appropriate remedial action for the Respondent to propose for groundwater within the pre-GMZ and eventual final GMZ. However, the State reserves its right to request or order further measures in the manner set forth herein, and Respondent reserves all rights it may have to object to any such requests or orders in the manner set forth herein.

7. By entering into this Consent Decree, the State does not hereby waive or attempt to waive any private right of action on behalf of any other party.

8. There has been no trial on any issue of fact or law in this matter and no judicial determination of liability. The Respondent does not, by entering into this Consent Decree, nor with respect to the Completed Work, admit to any wrongdoing or liability and nothing herein shall be interpreted as such an admission. The parties have reached this agreement in order to proceed with the prompt implementation of the remedial actions described herein without the expense and uncertainty associated with litigation of the issues covered by this Consent Decree.

NOW THEREFORE, it is ORDERED, ADJUDGED and DECREED as follows:

B. JURISDICTION AND VENUE

9. This Court has jurisdiction over this matter pursuant to RSA 491:7, RSA 498:1.

10. Venue is proper in Merrimack County because the Department is located in Concord, New Hampshire.

11. For purposes of this Consent Decree and the underlying Petition, including any further action to enforce the terms of this Consent Decree, the Respondent waives any and all objections it may have to the Court's subject matter or personal jurisdiction.

C. PARTIES BOUND

12. This Consent Decree is binding upon the State, including any agencies or offices acting under the authority of the State, and Respondent, including its successors and assigns.

D. DEFINITIONS

13. "Bedford Water System" means the public water system in Bedford, New Hampshire owned and operated by the Pennichuck Corporation.

14. "Contaminant" means any material regulated as a contaminant under New Hampshire law.

15. "Contamination" means the presence of any contaminant, other than naturally occurring substances at naturally occurring or background levels, in soil, groundwater, soil gas, air, sediment, surface water, construction/excavation debris, or any other material at a concentration that has the potential to adversely affect human health or the environment, as defined in Env-OR 602.07.

16. "Effective Date" means the date that both parties sign the Consent Decree.

17. "Groundwater" means subsurface water that occurs beneath the water table in soils and geologic formations, as defined in RSA 485-C:2.

18. “Groundwater Management Zone” or “GMZ” means the subsurface volume in which groundwater contamination allegedly associated with a discharge from the Property is contained as defined in Env-OR 602.14.

19. “Litchfield Water System” means the public water system in Litchfield, New Hampshire owned and operated by Pennichuck East Utility, Inc., a wholly-owned subsidiary of Pennichuck Corporation (collectively “Pennichuck”).

20. “Merrimack Water System” means the public water system in Merrimack, New Hampshire owned and operated by Merrimack Village District (“MVD”).

21. “Natural attenuation” means a reduction in the mass, toxicity, mobility, volume, or concentration of contaminants by physical, chemical, or biological processes without human intervention, as defined in Env-OR 602.16.

22. “Natural Resource Damages” or “NRD” means compensation for the diminution in value of any resource such as groundwater or surface water pursuant to any statute, rule, or other theory of recovery. NRD shall include the cost of restoring any resource to its baseline condition, compensation for the interim loss of use or value, including any existence or contingency value, of the injured resource, and the costs of any natural resource damage assessment. NRD does not include the cost of remediation or monitoring of any natural resource.

23. “Remediate,” “remediated,” “remediation,” or “Remedial Action” means any measure or combination of measures that will, when implemented, ensure attainment of a level of control of contaminants such that no contaminant will adversely affect human health or the environment, as defined in Env-OR 602.27.

24. “Water supply well” means any well that serves as a drinking water supply, including any well serving a public water system, as defined in Env-OR 602.35.

E. RESPONDENT’S OBLIGATIONS

25. Municipal Water System Expansions: In addition to the water system expansions that the Respondent has already paid for, the Respondent shall ensure² that the following additional expansions of the municipal water systems³ in the Towns are completed at the earliest possible time but no later than November of 2019 subject to the provisions of this paragraph:

a) *Bedford Water System*: The Respondent shall contract with Pennichuck and ensure completion of permanent connections to each property in the Town of Bedford listed in Exhibit D and depicted in Exhibit E and shall provide for decommissioning of existing wells should the property owner so choose;

b) *Litchfield Water System*: The Respondent shall contract with Pennichuck and ensure completion of permanent connections to each property in the Town of Litchfield listed in Exhibit D and depicted in Exhibit F and shall provide for decommissioning of existing wells should the property owner so choose;

c) *Manchester Water System*: The Respondent shall contract with Manchester Water Works and ensure that curb stops are provided to each undeveloped property in the City of Manchester listed in Exhibit D and depicted in Exhibit E;

² With respect to obligations in this Consent Decree such as water connections, point-of-entry treatment “POET” installation, and decommissioning, the Respondent shall pay for the activity and enter into appropriate and customary contracts with the applicable water authorities and/or duly licensed contractors providing for the activities to be completed. The Respondent shall be responsible for ensuring that the work described herein is actually completed but will not be subject to contempt penalties or any other penalties with respect to any delays resulting from a failure of the contractor or other third party or delays resulting from impossibility or force majeure provided the Respondent has made all reasonable efforts to ensure completion of the projects on time.

³ If the State agrees in writing that a property is currently an undeveloped lot, a curb stop or stub shall be provided to the property such that a future developer may connect to the water line. The Respondent shall not be responsible for the cost of any future connection to the curb stop or stub.

d) *Merrimack Water System*: The Respondent shall ensure that permanent connections are completed to each property in the Town of Merrimack listed in Exhibit D and depicted in Exhibit G and shall provide for decommissioning of existing wells should the property owner so choose.

To the extent any property owners identified in Exhibit D elect not to be connected to municipal water or elect to retain their non-potable wells, the State shall not direct or require the Respondent to connect such properties in the future, otherwise provide any form of alternate water or water treatment for such properties, or direct or require the Respondent to pay for the decommissioning of any wells at such properties or any other activities related to such wells. To the extent any property owner located in an area of the Towns where the extension of water lines has already been completed, i.e., the Completed Work areas, elected not to be connected to municipal water or elected to retain their non-potable well, the State shall not direct or require Respondent to connect such properties in the future, otherwise provide any form of alternate water or water treatment for such properties, or direct or require the Respondent to pay for the decommissioning of any wells at such properties or any other activities related to such wells, even if the properties are subsequently sold or otherwise transferred or conveyed.

The parties understand that time is of the essence for completion of the work set forth in this Paragraph but that Respondent is not performing the work itself and the time for completion of the work is beyond Respondent's exclusive control. Respondent shall undertake its best efforts to initiate the contracting process that will provide for the design, as necessary, and execution of the work set forth in this Paragraph within 60 days following the court's approval of the Consent Decree.

26. Point-of-Entry Treatment Systems: In lieu of paying for water lines to be extended to certain properties, the Respondent may request to pay for and install point-of-entry treatment (“POET”) systems at certain properties within the pre-GMZ or final GMZ where the use of a POET would be reasonable and cost effective subject to the State’s approval in writing of the use of POET systems at those properties. Approval shall be at the sole discretion of the State, but such approval shall not be unreasonably withheld. As of the Effective Date, the Respondent has proposed to provide POET systems to the properties listed in Exhibit H, and the State has approved POET systems at such properties. The State shall not demand or require the Respondent to pay for municipal water lines to be extended to any of the properties listed in Exhibit H or any other properties within the GMZ on which the Respondent installs a POET system provided the State agrees to the installation of such POET system. Respondent shall pay the costs of required operation and maintenance of such POETs for at least seven years and subsequently thereafter until: (a) sampling demonstrates that the groundwater is below the State’s AGQS as defined in Env-Or 602.02; and (b) three consecutive rounds of annual sampling do not show an upward trend in PFC concentration, unless the Parties otherwise agree to a shorter period of time.

27. Establishment of Groundwater Management Zone: Working with the Department, the Respondent shall propose a finalized GMZ in accordance with the requirements of Env-Or 600 et seq. following completion of a Site Investigation. Respondent shall comply with all regulations related to a GMZ, as applicable, and the Department shall not unreasonably condition its issuance and reissuances of the related Groundwater Management Permit. Based upon the investigation completed to date, the Parties have established the pre-GMZ, as depicted in Exhibit C. However, the GMZ may be revised as additional information becomes available

and will be finalized in accordance with the requirements of Env-Or 600 et seq. In connection with the establishment of the GMZ, the State shall use its best efforts, including but not limited to hosting public information sessions and meeting with Town officials in coordination with and including active participation from the Respondent,⁴ to work with the Towns to facilitate the adoption of any ordinances or other actions by the Towns that may be necessary to implement the GMZ or any other remedial measures required by this Consent Decree.

28. Conduct of Site Investigation and Proposal of Remedial Action Plan: The Respondent shall conduct all required site investigation activities required by Env-Or 600 et seq., and shall submit same to the Department for review. The Respondent, thereafter, shall submit a proposed remedial action plan to the Department for review and approval and, thereafter, implement the remedial action plan as approved by the Department to address groundwater within the GMZ pursuant to Env-Or 600 et seq.

The Parties anticipate that, given the current concentrations of PFCs, their distribution, and their potential source, MNA, along with monitoring and other similar ancillary measures as well as providing safe drinking water, will be an appropriate remedial action for the Respondent to propose in its remedial action plan to address groundwater in the GMZ for all areas other than source areas, i.e., areas of high concentration of PFCs attributable to the Respondent that require treatment to prevent the further spread of PFCs, to the extent any such source areas may be found to exist. Were the Department to approve MNA and associated measures as the remedial action, and if monitoring of groundwater within the GMZ were to indicate that MNA was not sufficiently protective of human health and the environment, the Department may request that the Respondent perform additional remedial activities. Such a request shall be consistent with the Department's relevant regulations and shall not be unreasonable. If the Respondent were to

⁴ The costs for State personnel to plan, host, and attend such meetings shall be cost recoverable.

disagree with any determination by the Department that additional remediation were necessary and the Parties were unable to agree on any further remedial activities, the Parties agree to participate in non-binding mediation within 30 days of a request by either party. To the extent an agreement still cannot be reached, the Department may issue any order it deems necessary, and the Respondent specifically reserves its rights to challenge, through appeal or otherwise, any such order. To the extent an appeal is heard by the New Hampshire Supreme Court, the Parties agree to participate in the Court's mediation program. If the Department believes that a situation constitutes an emergency, it may use those emergency powers granted to it without participating in the aforementioned dispute resolution. The agreement to mediate disputes as provided herein shall in no way be interpreted to limit the authority or discretion of the State. It is merely the intention of the parties to communicate effectively and efficiently.

29. Nothing herein relieves the Respondent of any obligations it may have to conduct site investigation, remedial investigation, or remedial actions on the Property.

F. RELEASE

31. Except as provided in Paragraph 32 below, the State agrees to the following releases: The State fully releases with prejudice all claims or causes of action it has asserted or may assert, against the Respondent (including any of the Respondent's past and present parents, subsidiaries, predecessors, successors, affiliates, officers, employees, representatives, directors, partners, principals, general partners, limited partners, agents, stockholders, shareholders, or owners) under any federal, state, or common law or other legal theory of liability in relation to the presence of PFOA, PFOS, or any other per- or polyfluoroalkyl substance ("PFAS) that may be regulated as a contaminant in the future in groundwater or water supply wells for the Addressed Properties, including, but not limited to, claims for Natural Resource Damages, as defined herein. In addition, the State fully releases with prejudice any claims for Natural Resource Damages, as defined herein, against the Respondent (including any of the Respondent's past and present parents, subsidiaries, predecessors, successors, affiliates, officers, employees, representatives, directors, partners, principals, general partners, limited partners, agents, stockholders, shareholders, or owners): (a) inside of the pre-GMZ; (b) between the pre-GMZ and the line labeled "Outer Boundary"; and (c) outside of the line labeled "Outer Boundary," all as shown on Exhibit C. The State further fully releases with prejudice all claims or causes of action it has asserted or may assert, against the Respondent (including any of the Respondent's past and present parents, subsidiaries, predecessors, successors, affiliates, officers,

employees, representatives, directors, partners, principals, general partners, limited partners, agents, stockholders, shareholders, or owners) under any federal, state, or common law or other legal theory of liability in relation to the presence of PFOA or PFOS in groundwater or water supply wells for the area outside of the line labeled "Outer Boundary" as shown on Exhibit C but only to the extent that such claims or causes of action relate solely to a lowering of the currently existing AGQS.⁵

Nothing herein shall be interpreted to place a requirement on the Respondent to perform any remediation in the area located between the pre-GMZ and the "Outer Boundary" line or area outside of the line labeled "Outer Boundary" in the future, nor shall anything herein be deemed an admission that Respondent is liable for any remediation in such area. The State acknowledges that there are other sources of PFCs in these areas, and the Parties reserve their respective rights and defenses in the event that the State requires additional remedial activities in these areas in the future. The State further acknowledges that should it require additional remedial activities in these areas in the future, the remedial alternative shall be selected and implemented in accordance with the Department's relevant regulations and municipal water line extension shall not be the presumptive remedy.

32. The State reserves, and this Consent Decree, including the release provided for in Paragraph 31 above, is without prejudice to, all rights and claims the State may have against the Respondent related to the following:

- a. Respondent's failure to satisfy any term or provision of this Consent Decree;
- b. Respondent's liability for any contamination other than what has been specifically released in Paragraph 31 above;

⁵ Currently, the AGQS for PFOA and PFOS is 70 parts per trillion.

- c. Respondent's liability for any contamination arising from unlawful discharges from the Property that occur after the Effective Date of this Consent Decree;
- d. Respondent's liability for any additional remediation required by the Department for contamination within the GMZ pursuant to Paragraphs 27 through 29 above;
- e. Respondent's liability for any remediation of soil, sediments, surface water, or other media within the GMZ;
- f. Criminal liability arising from future activities or information unknown to the State on the Effective Date;
- g. Civil penalty liability arising from future activities or information unknown to the State on the Effective Date;
- h. Cost recovery; and
- i. Respondent's responsibility under other regulatory programs such as those related to air emissions.

G. EFFECT OF SETTLEMENT

33. Nothing in this Consent Decree shall be construed to create any rights in, or grant any cause of action to, any person not a party to this Consent Decree.

34. The Respondent expressly reserves all rights, including, but not limited to, any right to indemnification or contribution, defenses, claims, demands, and causes of action it may have concerning any matter, transaction, or occurrence, whether or not arising out of the subject matter of this Consent Decree, against any person not a party to this Consent Decree. In addition, Respondent expressly reserves all rights, including, but not limited to, any right to indemnification or contribution, defenses, claims, demands, and causes of action it may have concerning any action brought by the State pursuant to one of the reservations set forth in Paragraph 32 above.

H. OTHER TERMS

35. This Consent Decree and all obligations assumed hereunder shall apply to and be binding upon the Respondent, its successors, and assigns. Actions or inactions of the Respondent's officers, directors, contractors, agents and employees, or firms, subsidiaries, divisions or other corporations acting under or for the Respondent, involved in the implementation of this Consent Decree shall be considered actions or inactions of the Respondent.

36. Any modification or amendment to any portion of the requirements for performance specified herein is subject to, and shall be effective only upon, the prior written approval of the State which approval shall not be unreasonably withheld.

37. The Court shall retain jurisdiction to enforce, including by contempt order, the terms and conditions of this Consent Decree, to make modifications necessary to effectuate compliance with the Consent Decree, and to resolve all disputes arising hereunder as may be necessary or appropriate for the construction and execution of this Consent Decree.

38. It is the intention of the parties that this Consent Decree be entered and enforced as an order of the Court. However, this Consent Decree also constitutes an agreement binding upon the parties at the time of signature.

39. Any Party's failure to enforce any provision of this Consent Decree after any breach or default shall not be deemed a waiver of its rights with regard to that breach or default, nor shall such failure be construed as a waiver of its right to enforce each and all of the provisions of this Consent Decree upon any further breach or default.

40. This Consent Decree shall be construed in accordance with the laws of the State of New Hampshire.



Pennichuck Water Service Connection Forms

Dear Sir or Madam:

In response to the discovery of per- and polyfluoroalkyl substances (PFAS) in groundwater in your area, the New Hampshire Department of Environmental Services (NHDES) has been working with Pennichuck Water and Saint-Gobain Performance Plastics (Saint-Gobain) to ensure that safe, clean drinking water is made available to you. Extension of Pennichuck's public water system has been under construction in your area this fall. Records of Pennichuck Water indicate that you have not yet returned the completed forms necessary for connection to water service that is, or will soon be, available in your area. NHDES is writing to inform you that all of the forms you received from Pennichuck must be signed and received by Pennichuck before work can be conducted on your property.

Contractors hired by Pennichuck for the project are expected to complete their work by the end of December. Service crews are currently installing service lines from the water shutoff at the street to homeowners' basements. In order to schedule the work and have the service lines installed before the contracts expire, it is important for Pennichuck to have all service application paperwork submitted as soon as possible, but no later than **November 30, 2020**.

As you may know, the full cost of connecting to the water main and either decommissioning your well or connecting your well to an outside faucet(s) and/or irrigation system is being paid for by Saint-Gobain. However, once the service contractors' contracts are completed, NHDES will consider Saint-Gobain's obligation to provide alternate water to affected properties to have been satisfied. If your property is not connected to the water main prior to contract completion, Saint-Gobain will no longer be required by NHDES to pay the cost of making the connection or providing bottled water in the future. If you decide to connect to the water main after **November 30, 2020**, you will be responsible to pay the cost of the connection.

In order to ensure prompt access to safe, clean drinking water for you and your family, we strongly encourage you to return the required forms to Pennichuck as soon as possible. The following forms are required for the connection:

- Application for Service Installation
- Customer Application
- Customer's Acknowledgement and Agreement Regarding High Pressure Service (*This form is only required for some installations*)(Signatures must be notarized)
- Existing Private Well Election Form

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty One

AN ACT requiring parties responsible for pollution of a drinking water supply to be financially responsible for certain consequences of that pollution.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 New Section; Drinking Water Pollution; Responsibility for Damages. Amend RSA 485 by
2 inserting after section 17-a the following new section:

3 485:17-b Drinking Water Pollution; Responsibility for Damages. Whenever the commissioner
4 finds a public or private corporation, individual, partnership, or other entity has violated the
5 provisions of this chapter, any rules in force hereunder, or any condition in a permit issued under
6 this chapter, then:

7 I. The public or private corporation, individual, partnership, or other entity shall connect
8 any residence or business affected by such violation to a commercial or municipal water supply at
9 the public or private corporation, individual, partnership, or other entity's cost.

10 II. The public or private corporation, individual, partnership, or other entity shall supply
11 drinking water to the affected residence or business until the connection required in paragraph I is
12 made, at the a public or private corporation, individual, partnership, or other entity's cost.

13 III. If the connection required in paragraph I cannot be made in 6 months or less, the public
14 or private corporation, individual, partnership, or other entity shall pay for the installation of a
15 whole house water filter and the maintenance of such filter.

16 IV. The public or private corporation, individual, partnership, or other entity shall pay the
17 owner of the residence or business affected by the violation a monthly sum based on the average
18 water usage and billing of comparable residences or businesses for 5 years from the date of the
19 connection required under paragraph I or until the residence or business is sold to a different owner,
20 whichever comes first.

21 V. Any owner of a residence or business that was affected by such a violation on or after
22 January 1, 2016 may inform the public or private corporation, individual, partnership, or other
23 entity of such effect in order to qualify for the remedies under paragraphs I through IV.

24 2 Effective Date. This act shall take effect upon its passage.
