
New Hampshire Gas, Dual Gas & Electric

On October 6, 2023, Northern Utilities, Inc. (Northern) filed a petition requesting that the Commission approve its natural gas capacity agreements with Portland Natural Gas Transmission System (PNGTS) and TransCanada Pipelines Limited (TCPL) on an expedited basis. In support of its petition, Northern submitted the pre-filed direct testimony of Unitil Service Corp. employee Francis X. Wells, Manager of Energy Planning (Wells Testimony), and related attachments. In addition, Northern filed a motion for protective order and confidential treatment.
