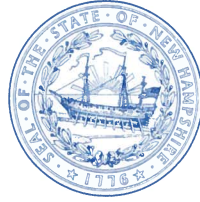

The Commission has scheduled a public comment hearing to address the proposed changes on **February 23, 2018, at 10:00 a.m.** In addition, written comments regarding the recommended program changes may be submitted until February 27, 2018.

Subsequent to the receipt of public comments, the Commission will determine the appropriate changes to be made to the Commercial and Industrial Solar Rebate Program, the timeline for implementation of such changes, and the provisions for transition from the existing to the new program parameters. Public notice of these program changes will then be issued through Commission order and new application forms will be prepared for use by rebate applicants.
