During the period of 12/08/2010 through March 31st, 2011, the NH Pay for Performance Program has been engaged in the following activities.

The single biggest challenge to date has been the pending legislation regarding the Renewable Greenhouse Gas Initiative (RGGI) and the possibility that it may be repealed. Many potential participants as well as program partners are very concerned and hesitant to get involved with the NH P4P Program until the active legislation regarding RGGI settles out. While at the time of this being written, it appears as if the current amendment being proposed by Senator Bradley would fund the NH P4P program completely (as well as other already committed grant funds) – and only redirect future RGGI funds to the core programs – it is still a complete unknown at this point. Until this situation resolves (one way or the other), we really can't expect to have widespread engagement in this program, and that is certainly a major obstacle we've been running up against in nearly every discussion with partners and participants.

5) Summarize work to be completed next quarter.

The plan for next quarter is really made up to two parts. The first part is to continue to market and raise awareness about the program in an effort to ensure that all large energy users in the state are aware of how the program operates, and how to become involved, as well as the benefits that would accompany their involvement. Ideally, we'd like to bring in the bulk of our projects for the program over the course of the next several months – so as to ensure that all projects have adequate time for construction and monitoring.

The second element of the plan for next quarter is to support those projects that are either getting underway, or are already underway. This would include reviewing new project applications, and reviewing and supporting the development of project-specific energy reduction plans.

One really great partnership we've been developing is our relationship with the NH Manufacturing Extension Partnership. We have met multiple times with Zenagui Brahim (director) regarding their involvement in the NH P4P Program, and have come to an understanding that they would best be able to serve their members, as well as the NH P4P Program by coming in as specialized program partner. The NH MEP specializes in finding waste in manufacturing processes using what they refer to as a "value stream mapping" and the utilization of a "lean green energy" approach to finding and removing waste in a facility (excess energy would be considered waste). This skillset is unique to our current list of program partners, and we're very excited to have them on board as a part of the program – as we believe this really allows us to support and target those larger process-based industrial customers where before they might be less likely to get involved in the program.
