- Work with the Jordan Institute on promoting the Program to their client schools via a letter. Letter sent out on November 17, 2009.
- Presented the Program to the Nonpublic School Advisory Council at their meeting on November 13, 2009.
- Promoted the Program at the NH Local Government Center's annual conference "Rising to the Challenge" on November 18 20, 2009.
- Promoted the Program at the NH Office of Energy and Planning's EECBG Workshops held in four locations throughout the State in January 2010.

Benchmarking

- Currently have ten (10) school districts enrolled in the Program, with a total of 35 school buildings undergoing benchmarking
- The benchmarking system requires approximately 50 buildings in order to calculate comparative Statewide statistics. Therefore, no full reports have been completed yet but a few districts have requested interim reports while the database is being populated.

4. Summarize work to be completed next quarter: Feb. 1, 2009 – Apr. 30, 2009

Adapt Building Energy Performance System to NH

- As first reports are generated, modify database as necessary
- We are integrating EPA's automated benchmarking system into our benchmarking
 data tracking and analysis database application. This allows us to decrease the cost
 and effort to benchmark buildings by eliminating duplicate data entry. It also
 ensures a higher level of data quality by eliminating a potential source of data entry
 error and enables us to more quickly recalculate scoring metrics when the EPA
 changes their rating systems.
- We are also working on more sophisticated data analysis and reporting options including ad hoc query support.

Marketing and Outreach

- Continue to collaborate with the NH Department of Education
- Further develop marketing and outreach plan
- Collaborate with Local Energy Committees through existing channels (i.e., Clean Air-Cool Planet)
- Collaborate with the Jordan Institute on providing complementary services to schools
- Collaborate with other RGGI grantees, utilities, US EPA and others on promoting the benchmarking services
- Develop case studies on completed reports once the required minimum of schools is reached

Benchmarking
