- **Residential**
 - HpwES (*Miles/Caryl*)
 - DONE: HPwES impact results memo—applied to 2020 plan
 - IN PROGRESS: non-part survey, non-part contractor interviews, literature review
 - Final report estimated in late Fall
 - HEA (*Miles*)
 - DONE: Part survey, desk reviews, site visits, PA and CAP interviews
 - IN PROGRESS: Non-part survey, engineering models, lit review, NEI analysis
 - Final report estimated in late Fall
 - New: Cross-state Gas Peak Demand Reduction study (Liberty/Unitil) (*Eric*)
 - Possibility to join with MA and CT on Navigant study on study of residential end use consumption and peak demand for gas
- **C&I**
 - C&I Non-lighting (*Mary*)
 - Final Report delivered for EM&V WG sign-off as “final”, including site level details
 - Standalone results for RGGI Retail & Large B? Or keep as is?
 - Cross-state Demand Response evaluation (Eversource/Unitil)
