To the Parties:

On July 26, 2021, the Town of Durham, City of Dover, City of Portsmouth, City of Somersworth, Town of Newmarket, Town of Exeter, and Town of Newington (Municipal Parties) jointly filed a signed "Stipulation of Dismissal", without prejudice, of their complaint against Consolidated Communications of Northern New England Company, LLC d/b/a Consolidated Communications-NNE (Consolidated) filed on July 1, 2020 (stipulation), as well as the City of Dover's supplement to the complaint and the City of Somersworth's supplement to the complaint (collectively, the supplements). The stipulation was also signed by Consolidated. No objections to the Municipal Parties' stipulation were filed.

The Commission will construe the stipulation as the Municipal Parties' request to dismiss the foregoing complaint and supplements, to which no objection has been made. Accordingly, the Municipal Parties' complaint against Consolidated and supplements have been dismissed without prejudice, and this docket will now be closed.
