STAFF'S MOTION TO OBJECT TO CITY OF NASHUA'S MOTION TO LIMIT DATA REQUESTS

The Staff of the New Hampshire Public Utilities Commission ("Staff") objects to the City of Nashua's ("Nashua") Motion to Limit Data Requests. In support of this objection, Staff states as follows:

- 1. By way of Order No. 24, 457, issued on April 22, 2005, the Commission approved a procedural schedule for this docket.
- 2. Puc 204.04 allows parties to object to data requests. Pursuant to Order No. 24,457, the Commission extended the four (4) day objection deadline to ten (10) days at the behest of the Staff and Parties.
- 3. Also pursuant to Order No. 24,447, the Commission made clear that it would be available to address discovery disputes as they arise.
- 4. To date, Staff is not of the opinion that existing safeguards to limit discovery are not effective.
- 5. After the threshold of ineffectiveness has been established, Staff would be willing to discuss with the Parties setting limits, such as those raised in the City of Nashua's motion, on discovery.

WHEREFORE, Staff respectfully requests that the Commission:

A. Deny Nashua's Motion to Limit Data Requests; and

B. Grant such other and further relief as the Commission deems necessary

and just.
