Dear Ms. Howland:

This letter responds to the Commission's request for a report from Staff following completion of the procedural schedule approved by secretarial letter dated January 14, 2009.

Briefs, reply briefs, and calculations of disputed charges and refunds/credits owed were submitted by parties in accordance with the approved schedule. Each party-intervenor reached agreement with Verizon on calculations of disputed charges and refunds/credits owed on a month-to-month basis through February 2008. As a result, there was no need to hold the Staffmediated break-out sessions scheduled in the January 14 secretarial letter.

Staff's discussions and correspondence with the parties resulted in the following agreed-upon timelines for next steps in this proceeding:

By Friday, February 20, 2009:

- 1. Each party-intervenor will file jointly with Verizon a reconciled month-to-month accounting of CCL charges up through the February 2008 billing cycle.
- 2. Verizon and Qwest will file a month-to-month reconciliation through February 2008.
- 3. Party-intervenors will work with Verizon to reconcile CCL charges billed and payments received by Verizon in March 2008.

## By Friday, March 27, 2009:

- 4. Verizon will work with FairPoint to reconcile amounts paid by party-intervenors to FairPoint after close (April 1, 2008) for services rendered by Verizon prior to close.
- 5. FairPoint will confirm payments it received and amounts, if any, it credited to party-intervenors in March and April 2008.

## April (date TBD):

- 6. Staff will meet with Verizon and FairPoint to resolve any transition and cutover-related issues concerning billing, accounts receivable, and credits, if any, in March and April of 2008.
- 7. Upon resolution of the above, Verizon and FairPoint will work with party-intervenors to reconcile the March and April 2008 accounting.
