

AT&T COMMUNICATIONS OF NEW ENGLAND, INC. ESTIMATE OF IMPROPERLY BILLED VERIZON NEW HAMPSHIRE ACCESS CHARGES

Pursuant to the Procedural Order, dated November 29, 2006 (Order No. 24,705), AT&T Communications of New England, Inc. ("AT&T") hereby files its estimate of the general order of magnitude of the disputed charges billed by Verizon.

AT&T's estimate of the amount of improper access charges as of the end of November 2006 ranges from [REDACTED] to [REDACTED] depending upon the start date for estimating the improper charges.

In order to calculate its estimate, AT&T ran a monthly usage report of switch usage in New Hampshire and filtered the data by ACNA, Jurisdiction, and Direction (termination vs. originating), among other factors. AT&T then calculated the minutes of use ("MOU") to which the CCL was improperly applied by subtracting the Local Switching MOUs from the CCL MOUs. This yielded the excess MOUs subject to the CCL rate. The financial impact of improperly billing the CCL rate to the excess minutes was calculated by multiplying the CCL rate of \$.026494 times the excess CCL MOUs.

Enclosed as back up are spreadsheets showing these calculations and the disputed amounts by time period. AT&T considers the information contained in the spreadsheets

to be confidential and proprietary, as well as commercially and competitively sensitive.

AT&T is, therefore, providing the enclosed spreadsheets only to the Commission and requests confidential treatment thereof pursuant to RSA 378:43.

These calculations are based on the best information now available to AT&T.

AT&T reserves its right to amend these calculations in light of any further information that comes to light in the course of this proceeding. This calculation includes overcharges related to "local" traffic, for which Verizon has agreed to provide credit, but has not yet done so.
