

PETITION TO INTERVENE OF SEGTEL, INC.

Pursuant to Commission Rule 203.02, and RSA 541-A:32, segTEL, Inc. hereby petitions the Commission to intervene in Docket No. DT 06-067.

I. Statement of Interest.

segTEL is a facilities-based competitive local exchange carrier (CLEC) and competitive toll provider (CTP) currently operating in New Hampshire pursuant to Commission Order No. 23,208 issued on May 3, 1999 in Docket No. DT 99-048.

The docket in question involves a request for Commission investigation into certain terms of New Hampshire Tariff #84 including but not limited into how Verizon interprets its own Tariff in relation to CLEC wholesale customers and whether or not any prospective Tariff modifications are appropriate (June 23rd Order of Notice p.3 item (5)).

segTEL purchase substantial amounts of Verizon wholesale services via the tariff in question and may be affected by any Commission interpretation, evaluation, ruling, or change to this Tariff.

Accordingly, substantial interests of segTEL may be affected by this proceeding. See RSA 541-A:32(I)(b) (2003).
