# LEVEL 3 COMMUNICATIONS, LLC'S APPEAL OF NORTH AMERICAN NUMBERING PLAN ADMINISTRATION'S DENIAL OF NUMBERING RESOURCES

### **Motion for Confidential Treatment**

Pursuant to RSA 91-A:5, IV; RSA 378:43; and N.H. Code Admin. Rule Puc 203.08, Level 3 Communications LLC ("Level 3") hereby requests protective treatment for the information it has redacted from the Response to Staff Memorandum ("Response") which it is filing in the above-captioned matter. In support of this motion Level 3 states as follows:

- 1. Level 3 has today filed with the New Hampshire Public Utilities Commission ("Commission") a Response in the above-captioned matter in both redacted and unredacted form.
- 2. In the unreadacted Response, Level 3 has included information about specific customers, utilization of numbering resources, and rate centers in which it has exhausted numbering resources.
- 3. The information contained in the unredacted response is commercially or financially sensitive information which is deemed to be confidential under RSA 91-A:5, IV; RSA 378:43; and the Commission's rules for confidential treatment, Puc 203.08. Level 3 believes that it would be commercially harmed were this information to be made available to the public and hence to competitors, as the information is not general public knowledge or published elsewhere, measures have been taken to prevent dissemination of this information in the ordinary course of business, and the information pertains to the provision of competitive services.

## WHEREFORE, Level 3 respectfully requests that the Commission:

- A. Grant Level 3's Motion for Confidential Treatment of the unredacted Response to the Staff Memorandum; and
- B. Grant such other relief as is just and equitable.
